NETBOOK PAYMENT AGREEMENT

Please read this entire agreement carefully. All terms and conditions will be strictly enforced.

This agreement is between Napa Valley Unified School District ("NVUSD"), American Canyon High School ("ACHS"), the student receiving a Netbook ("Student"), and his/her parent(s) or legal guardian(s) ("Parent(s)"). The Student and Parent(s) --- in consideration of being provided with a Netbook, software, and related materials for use while a student at ACHS --- hereby agree to the follow terms and conditions:

Payments: Student/Parent(s) agree to pay \$35.00 per month for 19 months (August 2011 through May 2012; August 2012 through April 2013). Payments are due by the 10th of each month to the ACHS school site. Monthly bills will not be mailed home. Payment can be made by cash, check or credit card. Total cost of the Netbook is \$665.00 (19 payments of \$35.00 equals \$665). At anytime during the term of the agreement, the total outstanding balance can be paid in full. After this payment agreement has been fulfilled and the outstanding balance on the account is zero dollars, Student/Parent(s) retain sole ownership of the Netbook.

Ownership: Student/Parent(s) will retain physical ownership of the Netbook as long as monthly payments are paid in full. Failure to pay for two consecutive months will result in the surrender of the Netbook and forfeiture of all payments made to date. In the case of surrender, the Netbook must be in undamaged and in working condition or Student/Parent(s) will be responsible for repair and/or full replacement costs.

Equipment: Dell Latitude 2110 Netbook including a built in web cam, 802.11b/g/n wireless card, 2 USB ports, an 80GB hard drive and 2 GB RAM. The Netbook has the Microsoft Windows 7 operation system and Internet Explorer. All systems include ample RAM, hard-disk space and wireless network capability. ACHS will retain records of the serial numbers of all components within the Netbook.

Substitution of Equipment: In the event the Netbook becomes inoperable, ACHS has a limited number of spares for use while the Netbook is repaired. If a loaner Netbook is available while the Netbook mentioned in this agreement is being repaired, Student will have access to a loaner Netbook. If no loaner is available, the school provides computers in each classroom in case the Student does not have a Netbook. Monthly payments remain due during any repair period, and after the repairs are complete, the loaner Netbook must be returned to receive possession of the original Netbook is this agreement.

Warranty for Equipment Malfunction: NVUSD has purchased a three-year manufacturer's warranty covering parts and labor. Student/Parent(s) incur no additional charge for repairs covered by warranty. The warranty only covers damage to the Netbook caused by manufacturer's defects.

Responsibility for Damage: The Student is responsible for maintaining a 100% working Netbook at all times. The Student shall use reasonable care to ensure that the Netbook is not damaged. Refer to the *Standards for Proper Care* document for a description of expected care.

Responsibility for Electronic Data: It is the sole responsibility of the Student to backup necessary data as necessary.

Responsibility for Loss: Student/Parent(s) accept full financial responsibility in the event of the Netbook being lost, stolen or otherwise missing. In the event the Netbook is lost, stolen or otherwise missing, Student/Parent(s) will be billed the remaining balance for Netbook.

Legal and Ethical Use: All aspects of NVUSD's Acceptable Use Policy remain in effect. NVUSD will provide content filtering within the NVUSD network. However, NVUSD does not have full control of the information on the Internet or incoming email from a non-NVUSD email provider.
